Ms. Molly Ann Graham (DOB: 09/28/1991). She sought treatment for a mental health-related disorder that can be found in the DSM-V. I'm familiar with her emotional-mental history and with the functional limitations imposed by this mental health-related disorder.

Due to this emotional disorder, Ms. Graham has certain limitations coping with what would otherwise be considered normal, significant day-to-day situations, such as symptoms of anxiety (including persistent worry, emotional tension, difficulty maintaining calm and an inability to self soothe).

To help alleviate these challenges and to enhance her day-to-day functionality, I have prescribed Ms. Graham to obtain Emotional Support Animals. Her ESA pets are two dogs and a cat:

Winston and Honey Bee, Two ShihTzu weighing 5 lbs each, and Noir a House cat weighing 5 lbs. These animals are necessary for the mental health of Molly Ann Graham, as each pet provides essential emotional support that directly addresses different symptoms related to her condition.

- Winston (Dog – ShihTzu, 5 lbs): Helps promote emotional steadiness by providing consistent companionship and reassurance. Additionally, Winston supports relaxation and stress relief, primarily through petting.
- Honey Bee (Dog – ShihTzu, 5 lbs): Helps reduce emotional tension by offering calming interaction and a grounding presence. Additionally, Honey Bee supports emotional balance and calmness, primarily through petting.
- Noir (Cat – House cat, 5 lbs): Helps reduce anxiety by providing a calming presence. Additionally, supports emotional balance and relaxation, primarily through petting.

I am licensed to practice therapy and to prescribe ESA for treatment. My license number is MFT- 46136 and it was issued in 2008. This letter should suffice as proof of treatment and certification of obtaining and keeping these emotional support animals. I prescribe that Ms. Graham keep her Emotional Support Animals in her dwelling, in accordance with the Fair Housing Act and the Americans with Disabilities Act.
